Most importantly, we listened—centering survivor voices to drive programs that are more responsive, inclusive, and effective.

Innovation in victim services is about thinking differently, adapting with empathy, and finding new ways to walk alongside survivors on their path to healing. This report shares the stories, data, and milestones that demonstrate how, by embracing innovation, we have grown stronger—and so have the individuals and community we serve.

Highlights

Through the application of creative, effective ideas, collaborations, and programs, we enhanced impact, efficiency, reach, and sustainability.

- We increased counseling, trauma therapy, and advocacy hours to sexual assault survivors by 82% through the addition for more mobilized staff positions – providing services to survivors in settings that are more accessible to them.
- We added new permanent supportive housing and civil legal representation programs.
- We increased education and outreach programs by 11% through engaging Survivor Advocacy Panel (SAP) members and enhancing collaboration partnerships.

Filling the Gap: Why Arise Launched Permanent Supportive Housing for Survivors Facing Chronic Homlessness

Permanent Supportive Housing (PSH) is a long-term solution for people experiencing chronic homelessness, particularly those with serious physical or mental health conditions, substance use disorders, or disabilities. It combines affordable housing with supportive services to help individuals stay housed and improve their overall well-being.

Key features of permanent supportive housing:

- 1.It's permanent there are no time limits.
- 2.Supportive services participants have access to voluntary services including case management, mental health care, job readiness training, life skill development, etc.
- 3.Affordable housing is subsidized so that participants pay no more than 30% of their income toward rent.
- 4.Housing First Model it prioritizes providing housing without preconditions like sobriety or treatment compliance.

Survivors of domestic and sexual violence carry deep trauma—trauma that doesn't simply end when they find shelter. For many survivors who are also chronically homeless and living with disabilities, the struggle continues every day. They face unstable housing, overwhelming barriers, and systems often not designed to support long-term healing. Survivors need more than just a roof over their heads; they need a safe, stable place where healing can truly begin.

At Arise, all our housing programs follow a supportive housing model that pairs safe housing with compassionate, individualized services. We provide survivors with the care and resources they need to reclaim their lives. But over time, our housing team saw a painful pattern: survivors with complex needs, those who experienced repeated abuse and live with disabilities, were repeatedly returning to homelessness.

PSH is designed specifically for survivors who need long-term, stable housing paired with intensive, trauma-informed supportive services. This means not just a home, but comprehensive case management focused on healing from abuse, managing disabilities, and rebuilding lives. For many survivors, this stability is essential—not a luxury. Arise has housed nine households and is on track to welcome a tenth.

ARISE HOUSING OPTIONS

Emergency shelter is a 40-bed short-term housing option for individuals fleeing domestic violence.

Permanent Supportive Housing is a permanent housing option that can support up to 10 households per year.

Other supportive housing programs include transitional housing and rapid re-housing (rental assistance). Transitional housing is temporary housing assistance that lasts between 12-24 months, and rapid re-housing is permanent housing solutions that provide one year of rental assistance. Both programs can support up to 47 households per year.

Through the addition of permanent supportive housing and continued growth of transitional housing and rapid re-housing programs, this year Arise has increased the number of domestic violence survivors housed by 104%.

CIVIL LEGAL REPRESENTATION PROGRAM LAUNCHES

The Civil Legal Representation (CLR) program is Arise Lawrence County's legal aid office that provides limited civil legal representation to survivors of intimate partner violence in the following matters:

- **Divorce**
- Protection from Abuse Hearings
- **·Custody**
- **Support**
- ·Landlord-Tenant

Staffed by a full-time attorney and paralegal, the Arise CLR can also provide brief legal advice for individuals who may be unsure of their legal options.

This program opened for referrals beginning in January 2025.

MOBILIZED HEALTH CLINICS AND HEALTH FAIR BRING SERVICES DIRECTLY TO SURVIVORS

Survivors of interpersonal violence are often at a disadvantage when it comes to general well-being and health. Intimate partner violence can significantly impact both physical and mental health and lead to an increase in risk of chronic diseases, injuries, and mental health conditions. In addition to the increased risks, Arise is also aware how the impacts of violence can also hinder the ability for survivors to receive access to health services due to a variety of barriers.

To combat this, Arise has hosted mobilized health clinics on site over the past year to provide direct access to medical services for survivors. These mobilized health clinics have included once-amonth visits from Primary Health Network with their clinic on wheels, as well as Link the Valley, a mobilized dental clinic. These health clinics have become increasingly popular with participants, some of whom access healthcare services on a monthly basis.

In April 2025, Arise hosted a Community Health Day. Arise hosted Primary Health Network's mobile clinic, Link the Valley's mobile dental clinic, Adagio Health and their WIC office representative, and the PA Thrive Partnership. Services for the day included A1C/Lipids testing, STI/STD testing, general health and well being visits, dental cleanings and oral check-ups, WIC information and resources, as well as Arise resources and referrals. Dean Natural Vending, the Wilmington Road Giant Eagle, and McDonald's on W. State Street provided healthy snacks, donuts, and coffee for the day. We are extremely thankful for their generous support and donations.

As a result of the Community Health Day, Arise was able to provide services to over 28 survivors who took part in a variety of healthcare services. The next anticipated full community health day is slated for October 2025 as a part of Domestic Violence Awareness Month. In the meantime, keep a look out on our social media accounts for upcoming mobile health clinic days from Primary Health Network and other area providers.



ARISE HOSTS HUMAN TRAFFICKING TRAINING

On October 30, 2024, Arise hosted a regional training event in cooperation with the Lawrence County District Attorney's Office and the New Castle Police Department. This training was attended by law enforcement, attorneys, victim service providers, social workers, and other allied professionals. "Combatting Human Trafficking: A Cross-Systems Trauma-Informed Approach to Investigations, Prosecutions, and Victim Services" featured presentations by:

ARISE CAREER CAMPS

As part of the Office of Violence Against Women (OVW) Rural and Transitional Housing Grants, Arise has partnered with the New Castle branch of CareerLink to offer "Career Camp" for agency participants. "Career Camp" provides Arise participants the opportunity to attend a week-long workshop for job readiness. As part of this workshop, participants meet with staff from CareerLink who talk with them about programs and resources to explore careers, career assessments, applications and applicant tracking systems, financial literacy after securing a job, and positive attitude and soft skills.

At the end of the week each participant:

- completes a paper resume;
- · has an electronic version of their resume;
- · creates a career portfolio;
- · and, a Career Goal Flow Chart and Action Plan.

The next camp is scheduled for September 2025.

TEEN SUMMER CAMP

This past summer, our annual Teen Summer Camp returned for a powerful weeklong experience designed for youth impacted by domestic violence and sexual assault. The camp focused on guiding participants through meaningful conversations and activities centered on healing, self-discovery, and empowerment. Teens explored essential topics such as setting healthy boundaries, practicing self-care, and building selfesteem—all within a supportive and trauma-informed environment. In addition to daily workshops, campers enjoyed fun and engaging community outings that offered opportunities for connection, recreation, and joy. Teen Summer Camp remained a vital space for youth to grow, heal, and realize they were not alone on their journey.

COUNSELING GROUPS: A CORNERSTONE FOR HEALING

Over the past year, Arise has expanded its counseling services by offering a variety of counseling groups aimed at fostering healing, resilience, and personal growth for survivors of domestic violence and sexual assault. These groups have included the Self-Esteem Group, Survivor Social, Domestic Violence 101 (a dedicated men's group) and Self-Care Group for Emergency Shelter residents. Additionally, multiple groups were held at offsite community locations to ensure greater accessibility. Grounded in trauma-informed principles, each group created a safe, empowering space where participants could explore topics such as self-worth, boundaries, healthy relationships, and the dynamics of domestic violence and relationship abuse. Through shared experiences, compassionate facilitation, and peer support, these groups help individuals strengthen their coping skills, find connections, and reclaim their voices on the path to healing.

As part of our commitment to providing trauma-informed care, all Arise's counseling groups are grounded in the "A Window Between Worlds" (AWBW) curriculum and facilitation style. AWBW is an arts-based program that uses creative expression as a tool for healing from trauma. Earlier this year, 7 Arise staff completed specialized training in this program. The training equipped staff with the knowledge and skills to facilitate art workshops that offer survivors a safe, non-verbal way to explore emotions, process experiences, and build resilience. Rooted in traumainformed care, the AWBW approach emphasizes choice, empowerment, and emotional safety-core values that align with Arise's mission. By integrating this powerful program into each of our counseling groups, Arise is broadening the ways survivors can connect with themselves and others, fostering healing through creativity and compassionate support.

SURVIVOR ADVOCACY PANEL

Our Survivor Advisory Panel (SAP) is a survivor-led advocacy initiative we developed to strengthen our outreach and prevention work and ensure all services remain culturally relevant and survivor-centered. We intentionally engaged individuals with lived experience and offered paid, professional development opportunities as part of their involvement. Our goal was to center survivor voices in a way that not only informed our programming but also supported their autonomy and financial self-sufficiency through meaningful, reciprocal engagement.

Our SAP members have become an essential part of our agency's day-to-day work and special projects. They've helped us expand and improve our outreach by participating in community events, where they bring authenticity and connection to our prevention messaging. During the holiday season, some were instrumental in our Christmas donation operation helping to organize, wrap, and distribute gifts to the families we serve. Behind the scenes, they've reviewed our marketing materials and intake procedures, offering invaluable feedback that ensures our language and processes are welcoming, inclusive, and traumainformed. Two of our SAP members are also in the process of completing our introductory training which will enable them to provide direct services to our program participants, as peer advocates.

After a year on the project, here's what they want the community to know:

"You (Survivors) are not alone. There is safety, people who care and resources to help you through what seems scary and impossible, but together we can do hard things. There are more opportunities here for support and healing than you can imagine. Just make the call so you don't have to do it alone." – Shannon, SAP Member

"I am here to be a spokesperson for the defense of the rights of victims of domestic violence in this area of the country, in addition to becoming a link between the agency and the Latino community so that people feel more comfortable, safe and understood in their native language." – Lorena, SAP Member

ARISE SHOWCASES SUCCESS OF SAP PROGRAM AT NATIONAL CONFERENCE

Nicole Amabile, Chief Executive Officer, and Stephanie Benincase, Director of Counseling and Trauma Therapy Services, presented the workshop, "Lessons from the Field: Engaging People with Lived Experience to Inform Outreach and Prevention Work" at the National Sexual Assault Conference in Washington, D. C. in August 2024.

This workshop highlights Arise's success in the development and implementation of the Survivor Advocacy Panel (SAP) program. Drawing from our frontline work, we shared real-world examples of how survivor feedback has informed program design, shifted organizational practices, and guided our organizational priorities. We also explored the ethical and practical considerations involved in engaging survivors in advocacy—prioritizing safety, consent, and empowerment at every stage.

This opportunity helped elevate our work on a national platform, affirming the importance of survivor-centered approaches in creating long-term, systemic change. It also reinforced our commitment to ensuring that those most impacted by violence are not just heard—but are actively shaping the systems meant to support them.

This workshop presentation will also be presented at the 2025 Pennsylvania Coalition to Advance Respect (PCAR) State Conference, the National Organization for Victim Advocacy (NOVA) 51st Training Event, and the Pennsylvania Commission on Crime and Delinquency's 2025 Pathways Conference.

Arise Staff Wellness Program

We have established a comprehensive staff wellness program. It is well documented that people working in victim services are at a high risk for burnout, compassion fatigue, and vicarious trauma. To keep passionate and experienced advocates in the field, it is imperative that victim service agencies address these issues head on and promote resilience factors for staff. The Arise Staff Wellness Program promotes staff resilience through policy, programs, supervision, and creative partnerships.

- Trauma-informed supervision: Staff members engage in regular one-on-one meetings with supervisors who work to create emotionally safe environments, provide clear communication, and prioritize professional development and wellness to prevent burnout and compassion fatigue. Staff are encouraged to shape their own development paths with guidance focused on skills growth and maintaining high-quality client care.
- Professional Wellness Groups, facilitated by the Director of Counseling and Trauma Therapy, offer confidential spaces to process the emotional impact of client work. These sessions provide education on topics such as vicarious trauma, burnout prevention, and self-care.
- Recreation and Well-Being Committee that organizes wellness challenges, team-building events, and develops other resources for ongoing staff use, such as grounding kits and a self-care library.
- Corporate wellness partnership with Infinity Flow Studio that allows staff to enjoy deeply discounted yoga classes and memberships and established a comprehensive critical incident response plan that includes Accelerated Resolution Therapy sessions with a contracted provider, counseling co-pay reimbursements, and designated Wellness Days.
- Supportive employee policies and conflict mediation practices. At the policy level, we've adopted policies that promote work-life balance and affirm diversity, including paid parental leave, accommodations for various family and health needs, and transgenderinclusive policies.

These efforts are the beginning, as we will continue our focus and commitment to creating a safe, supportive environment where advocates can thrive personally and professionally.






